3 Location and Schedule

3.1 Location

ČAKOVEC Airfield (ICAO: **LDVC**)

5 km east of the city of Čakovec (**462331.54 N, 0163001.21 E**), at **513ft ASL**

Runaway: **1050 x 42m**, direction marking **03/21**.

Airfield is uncontrolled, **123,500 MHz**, the call sign is "**Chakovets Radio**".

A part-145 approved organization, Pan Aero Services LLC, is located at the airfield and is approved for the maintenance of gliders and aircraft, which will provide its resources for the needs of the competition.

4 Minimum Requirements

Pilots

- SPL or equivalent license
- At least 80h on gliders (PIC)
- Silver “C” badge or acquisition requirements
- Min. 5h in past 12 months in glider type flown in competition
- All competitors must have health insurance that covers emergency care, possible transport to the hospital and home, and subsequent treatment.

Gliders

- Valid ARC or PTF (until 11.04.2021.)
- Third Party Liability, min. 750 000 SDR.
- Glider must have the competition number marked on the tail
- IGC approved logger

5 Rules

- The competition will be held in the mixed class with a handicap factor according to the FAI sporting code and the valid FAI handicap list or the DAeC handicap list, to be determined.
- For the team prize, two competitors form a team.
- The scoring system will be applied according to the FAI sports regulations.
- The SeeYou competition software will be used .
- IGC approved loggers are used
- Planned competition area includes the northern part of Croatia, northern Slovenia and southern Hungary.
- The competition area, airspace and waypoints will be published.

The organizer does not take any responsibility in case of accidents, incidents or any damage not directly caused by the actions of the organizer. This policy also applies to the transport of gliders on the ground and when towing from another airport.
